**Conclusions:**

**FY2009 Annual Summary:**

- In FY2009, there were reported thirty-four (34) total out-of-state members served.
  - All of these members were Medicaid members.
  - Fourteen (14) were adults and twenty (20) were adolescents.
- Of the fourteen (14) adults served:
  - Eight (8) were reported from Wichita region
  - Four (4) were reported from Kansas City region
  - Two (2) were reported from the Northeast region
  - None were reported from the West, South Central or Southeast regions
- Of the twenty (20) adolescents served:
  - Eight (8) were reported from Wichita region
  - Seven (7) were reported from Kansas City region
  - Three (3) were reported from the Northeast region

- Two (2) were reported from the Southeast region
- None were reported from the West or South Central regions
- The services (in units) for these clients in FY2009 were:
  - Assessment (Adults 5 units/Adolescent 7 units)
  - Outpatient Group (Adults 320 units/Adolescents 1,596 units)
  - Outpatient Individual (Adults 316 units/Adolescents 657 units)
  - Adolescent IOP (62 units). There were no IOP services reported for Adults.
- When reviewing the service units reported for FY2009, the total units served in decreasing order are:
  - Adolescent Outpatient Group (1,596 units)
  - Adolescent Outpatient Individual (657 units)
  - Adult Outpatient Group (320 units)
  - Adult Outpatient individual (316 units)
  - Adolescent IOP (62 units)
  - Adolescent Assessment (7 units)
  - Adult Assessment (5 units)
- Based upon the service units reported above, the number of units for adolescents appears high compared to the adults' service units when you consider 59% of those served were adolescents and 41% were adults.
- The outpatient service units appeared to increase dramatically third and fourth quarters particularly for adolescents.

**Preliminary Recommendations to Committee:**

- It is recommended to the Committee that data trending continue.
- It is also recommended that ValueOptions investigate the Adolescent service units reported for third and fourth quarter and see if targeted outreach to provider(s) is needed. **ValueOptions had already conducted targeted outreach for a specific provider related to Adolescent Outpatient Group numbers.**
- Approval by the Committee is also requested to share this aggregate analysis at the Regional QI meeting and to be posted on the ValueOptions website for public access.
